RESOLUTION AUTHORIZING PURCHASE OF NEW VEHICLE

The Town Board of the Town of Chenango, duly convened in Regular Session, April 25, 2022, does hereby RESOLVE as follows:

WHEREAS, the Superintendent of Public Works of the Town of Chenango, Gregory Burden, has recommended the purchase of a 2022 Ram 4500 Ram Reg Cab & Chassis, for use by the Public Works Department to replace the existing 2001 Dodge Ram 3500, and

WHEREAS, Gregory Burden procured bids for such vehicle using the NYS OGS Vehicle Marketplace via Mini-Bid; and

WHEREAS, the Town Budget Officer has recommended that the funds for the purchase be taken from A7110.200 (Parks); and

WHEREAS, the Town Board of the Town of Chenango authorizes the purchasing of the 2022 Ram 4500 Reg Cab & Chassis from Main Motorcar, the low bidder under Mini-Bid Number 8780 at the price of \$47,978.24; and

WHEREAS, the Town Board upon review of said contract has determined the same to have been let in accordance with the General Municipal Law; and

WHEREAS, the Town Board has determined such purchase to be in the best interest of the Town of Chenango;
